Judo Canada is the national sport governing body for the sport of judo in Canada. The organization has the overall authority to provide leadership in promotion and development as well as govern all aspects of Judo in Canada including the selection and preparation of Canadian teams for international competition. Judo Canada is a not-for-profit Registered Canadian Amateur Athletic Association operating under a board of directors elected by provincial and territorial members.

To promote healthy judo participation across Canada and support judokas in achieving success at World Championships, Olympic and Paralympic Games.

2024-2026 BOARD OF DIRECTORS

Chair (2020-2022 – 2024-2026): Donna Hanson

Donna has dedicated 46 years to Judo, surpassing her involvement in other sports. Her resume highlights extensive experience across various aspects of Judo. As a former RCMP officer, she oversaw programs like Drugs in Sport and collaborated with organizations such as the Western Hockey League and Canadian Centre for Ethics in Sport. Her policing career spanned diverse disciplines, providing her with deep insights into working with Canadians of all ages, socio-economic backgrounds, and cultures.

Treasurer (2022-2026): Miguel Rueda

Miguel has been on the board of Judo Canada since 2022 as a director and sits on the Finance and Audit Committee since 2023. He has been elected as Treasurer in September 2024. A longtime volunteer at Judo Manitoba and has been refereeing at a high level since 2001. Miguel is currently employed as a Director, Ethics & Compliance for Air Canada.



General Secretary (2018-2026): Gerald Poirier

Gerald has been on the board of Judo Canada since 2018 as a director and General Secretary since 2022. He is a life judo instructor, volunteer and retired officer of the Canadian Armed Forces. He is also currently a member of the PJC Kata Committee.

Director at Large (2022-2026): Bernard Letendre

Bernard has been on the board of Judo Canada since 2022 as a director and also chairs the Governance and Ethics Committee since 2023. Over the course of his nearly 30-year corporate career, Bernard held executive and senior executive positions in some of Canada's largest financial institutions. A Certified Organizational Coach and a member of the Quebec Bar since 1993, Bernard is a Partner in organizational consulting firm Humance | Culture & Performance.

Director at Large (2024-2028): Jennifer Parker

Jennifer Parker has been practicing judo since 1990, and her passion for the sport has grown ever since. A silver medallist at the National championships, she later obtained her NCCP community coaching certification and has officiated at National and Continental level competitions. She was a French immersion teacher for over 14 years, earning her bachelor's degree in Elementary Education in 2001 and a master's degree in Elementary Science Education in 2015, both from the University of Alberta.

Director at Large (2020-2022 & 2024-2028): Alfredo Muñoz

Born into a family of Chilean immigrants, Alfredo Muñoz has been a judoka since 1975, with an athletic career that took him to the gates of the Barcelona Olympics in 1992, but which he missed due to a serious injury. After earning a bachelor's degree in physical education from the Université de Montréal, he began his career as a police officer with the SPVM. He returned to his studies, earning a law degree (LL.L.) from the University of Ottawa in 2021, leading to his call to the Ontario Bar. Today, at the helm of the Lex Facto law firm he founded,

Director at Large (2024-2028): Sandra MacDonald

Based on Prince Edward Island and a registered nurse, Sandra MacDonald owns a local commercial vehicle repair company and an oyster farming business. She had the privilege of participating in the construction of Canada's longest Confederation Bridge in the late 1990s. A judo athlete since childhood, she was Provincial and Maritime Champion before reaching seven national podiums.

Director at Large (2022-2026): Ruth Lam


